2. Client signs and returns License via fax or with 'real digital signature' as file attachment to email. (A 'Real Digital Signature' is a scanned image file of physical signature pasted into .doc or .pdf formatted license agreement.)
3. Upon receipt of signed License and confirmation of payment, Blumenberg Associates sends client image file via password protected email.
4. Digital files corrupted in transit via the Internet will be replaced at no cost after client returns corrupted file to Blumenberg Associates via email.

B. TERMS AND CONDITIONS -

1. 'Client' is defined as the Company licensing the image, not the individual signing this license for the company.
2. If the individual who signs this agreement on behalf of the Company as Client, leaves the Company that licensed the content, the company may continue to make use of the content pursuant to this agreement. The individual signatory may not make a copy or transfer the content to a new place of employment or to his/her own company.
3. Client may utilize the designated, licensed image as a design element within ONE commercial, for-profit, product.
